On posting the AWS of the BoR Customer-SPFS
software product, version 2024.4.2, and operation
manuals

Information notice No. VN-16-4-6-1/7859 dated 20 September 2024

Further to information notice No. VN-16-4-6-1/6452, dated 5 August 2024, the Payment System Operation Centre of the Information Technology Department (hereinafter, the PSOC ITD) informs exchange participants (hereinafter, EPs) that the Bank of Russia has posted the AWS of the BoR Customer-SPFS software product, version 2024.4.2 ('spfs2024.4.2.rar'), and operation manuals for the AWS of the BoR Customer-SPFS software product (hereinafter, the BoR Customer software¹) on its website www.cbr.ru/eng/development/mcirabis/information_FMS_clients in the section 'Automated workstation of a Bank of Russia customer using the Financial Messaging System'.

The list of the BoR Customer software operation manuals and changes to them are provided in the Annex hereto.

Please note that the folder extracted from the '*.rar' archive contains a 'hash.txt' file and '*.zip' archive. The 'hash.txt' file contains a list of the BoR Customer software controlled files and a hash code calculated based on the hash algorithm in accordance with GOST R 34.11-2012.

The archive was created using WinRAR 6.23.

Please be reminded that when the BoR Customer software is replicated to EPs using the Bank of Russia Transport Gateway to Exchange Payment and Financial Messages with Customers of the Bank of Russia (the BoR Customer TG) automated system, two information messages will be sent: a notification (about the replication of the BoR

Customer software) and an additional message with recommendations on how to check the integrity of the BoR Customer software.

The concurrent testing of the BoR Customer software at the CDPC-level RABIS-NP sub-systems test stand is available upon the receipt of the distribution kit.

The deadline for the transition to the BoR Customer software, version 2024.4.2, and the UFEBM Album, version 2024.4, is 22 September 2024.
